**OFFICIAL GUIDELINES – Sam Rittenberg Shred Event \$100 Mastercard Gift Card Giveaway**

**No purchase is necessary. Limit one entry per individual.**

**1. Prize Giveaway:**

One South Carolina Federal Credit Union ("Sponsor") member or non-member (giveaway participant) will win one \$100 MasterCard Gift Card. Prizes are awarded with no warranty or guarantee, either express or implied, by Sponsor. No substitution or transfer of prize permitted by winner. Sponsor reserves the right to substitute a prize of equal or greater value.

**2. Eligibility for Giveaway:**

- Participation is limited to U.S. residents.
- Must be 18 years or older to enter.
- Must be eligible for membership with Sponsor.
- Any Sponsor Members in good standing which is defined as, but not limited to, the following at the time of prize giveaway:
  1. Positive balance in all joint share accounts
  2. No past due loans or collections on any joint share or loan account
  3. No credit union restrictions on individual applicant
  4. Must comply with Sponsor's membership requirements
  5. Must comply with Sponsor's policies and procedures
- Employees, volunteers and related account may not participate. "Immediate family member" includes spouses; dependents; siblings; parents; biological or adoptive or step father, mother, brother, sister, son, or daughter, and each of their respective spouses; or individuals who reside in the same household, whether related or not.

The winner will be notified by 4.17.2025 by the phone number associated with the member's account number or entry form (non-member). If phone contact is not successful, notification will be sent to the mailing address associated with the member's account number or entry form (non-member). If the winner does not contact Sponsor **within two business days of being notified**, the prize will be forfeited and an alternate winner will be selected. Winner(s) must sign and return any required Gift Acceptance and Photo/Video Release Form within 3 days. Failure to sign and return the form within the applicable time period will result in forfeiture of the prize and Sponsor shall have the option, but not the obligation, to award the prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded.

You agree that all matters arising out of or relating to this sweepstakes and these Official Rules are governed by, and construed in accordance with, the laws of South Carolina, without giving effect to any of its conflict of laws provisions thereof. You further agree that any legal suit, action, or proceeding arising out of or relating to this sweepstakes and these Official Rules shall be brought exclusively in the applicable federal or state courts located in North Charleston, South Carolina.
